

# RULES

## CECCHETTI CHOREOGRAPHIC COMPETITION

- Competitors must be studying with a Cecchetti teacher.
- Competitors may dance in their own compositions and must comply with the age requirements. Dancers of any age may perform in their compositions. **All ages to be taken on the last day of February 2018.**
- Solos may nominate one choreographer. Duets may nominate two choreographers. Groups/Trios may nominate only one choreographer. If dancing in more than one item please write this on your application form. Details on entry forms cannot be altered once submitted.
- Dances must be entirely original and the sole work of the named entrant/entrants. Dances must not have been performed before, either at this competition or similar competitions, and should not have been performed, recorded or broadcast in any form of media prior to entry.
- Time limit: 

<b>Solo</b>	<b>1 ½ mins in all sections</b>
<b>Duets</b>	<b>2 mins in all sections</b>
<b>Trio/Group</b>	<b>2 ½ mins in the Junior and Middle sections</b>
<b>Tri/Group</b>	<b>3 mins in the Senior section</b>

Numbers running over time will be faded out. This will be regarded as disqualification.
- Tap dances are not accepted and classical dances should not be danced on pointe. Any form of gymnastic moves are performed at the competitor's own risk. **Please note the floor is unsuitable for acrobatic moves.**
- Costumes must be based on a leotard with at least half the leotard visible and only simple accessories as necessary. If this is not observed, competitors may be asked to simplify their costumes before performing. Masks covering the face are not acceptable. Small props can be used. Scenery is not permitted. No extra marks are awarded for costume.
- Competitors CD's will be collected upon arrival. The music must be at the beginning. On the cover only the competitor's name or the title of the dance must be CLEARLY marked. Please bring a spare CD copy of your music.
- Music for Junior and Middle sections must not contain vocals. Seniors may use music with vocals (please use your discretion and ensure the lyrics are appropriate.)
- Entry numbers must be returned and music collected at the check in desk in the foyer after the adjudication.
- There is a no food and drink policy during the competition. Participants will be provided with drinking water.
- The audience are to remain in their seats until the end of each section. Participants may not return to their parents until after their adjudication.
- If a participant is ill on the day and unable to perform in a duet or trio the other members of the dance may perform the piece but it will not be adjudicated.
- Competitors shall agree to abide by all the rules laid down for this competition and accept the Adjudicator's decision as final.

The Choreographic Competition encompasses all forms of dance with the exception of tap dancing and we welcome all interpretations of dance. Our adjudicators are invited from a diverse area of dance and musical background, the results on the day are their personal opinion. If time allows and the adjudicator feels it is appropriate they have the choice to comment on individual participants.

Children must try to use music by lesser known composers therefore avoiding famous compositions. The style of music needs to interpret the theme with use of appropriate movements. Divide or join pieces of music with sensitivity to maintain a good sound quality with a clear start and end without breaking the phrasing of the music. This will allow the children to create and express themselves with a flow of movement.

Tickets must be purchased in advance. Participants will not be charged to watch the competition.

NB: Children under 6 years of age will not be admitted into the auditorium.

Dancers will not be allowed to participate without photographic permission.

Spectators are **NOT** allowed to photograph participants during the competition. Photographs will be available to order after the competition, full details will be provided at the competition and printed in the programme.
